To provide for the possibility to continue studies in an identical or similar programme of study

This Dean's Directive is issued to implement Rector's Directive No. 9/2024, details on provision for the possibility to continue studies in an identical or similar programme of study in case of termination of accreditation and right to offer a programme of study under institutional accreditation:

Article 1 Subject Matter of the Directive

- 1. This directive provides the details and organisational matters enabling the continuation of studies in an identical or similar programme of study at the Faculty in case of termination of accreditation of the bachelor's, master's and follow-up master's programme of study entitled:
 - Medical Bioanalytics, field of study Medical Laboratory Technician
 - Pharmacy, study field Pharmacy
 - Medical Bioanalytics, study field Specialist in Laboratory Methods
- 2. The programme of study is specified and implemented through curricula.
- 3. A completion-of-study curriculum is designed for students to be able to complete their studies without any major changes in a newly accredited programme of study.

Article 2 Successor Programme of Study

The Internal Evaluation Board of Charles University determined that the following programmes and fields of study, whose accreditation has been terminated, are similar in terms of content to the following programmes of study:
